



**All Seasons Houseboats Winter 2018 Competition
TERMS & CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this competition is deemed acceptance of these Terms and Conditions.

Variables

3. The competition opens at 9am AEDT 1 June 2018 and closes at midnight AEDT 31 August 2018.
4. The two winners will be determined by random selection at 10am AEDT on 3 September 2018 and the name of the winners will be posted to All Seasons Houseboats Facebook & Instagram on 4 September 2018.

Eligibility

5. The competition is open to Australian residents only and staff and associated suppliers of All Seasons Houseboats & Holiday Park are not eligible to enter.
6. Entrants must be 18 years and over.

How to Enter

7. To enter, upload a photo of your current stay in June, July, August 2018 onboard on All Seasons Houseboat to Facebook or Instagram. You must "check in" through Facebook or "Add location" through Instagram to All Seasons Houseboats, Dockside Drive, Mildura.
8. On Facebook, "Like" the page and on Instagram, "Follow" the account.
9. By entering you have agreed to read these Terms and Conditions and be bound by these Terms and Conditions.
